#### Introduction

Sign-in sheets, agendas, notes, and evaluations will be kept on file to document stakeholder participation and any applicable feedback or suggestions to improve our academic data will be discussed during Leadership meetings and appropriate next steps will be put in place for implementation..

Description: In an effort to support parents in this new virtual learning environment these meetings will start off weekly. After the 1st quarter parents will be surveyed to determine future needs and parent meeting dates and times will be adjusted accordingly. During these meetings, Stakeholders will be given the opportunity to be updated on current school plans from the Administrative team via powerpoint, updates on instructional practices and the curriculum by grade level, academic progress, home school connection ideas, and parent expenditures. Parents will be able to freely express ideas and include any ideas for improvement. Once again, any ideas will be further discussed during Leadership Meetings for implementation.

Monthly PTA meeting (Initial meeting will provide an overview powerpoint of SPP Plan highlights)

Parents and Community Stakeholders will be given an overview of the Title I Components within the SPP which will include the Implementation Steps funded by Title I, a summary and distribution of the home compact, the parent engagement plan for the year, as well as an overview of the FY 22 budget. Stakeholders will be provided the opportunity to provide input on the Title I Components of the SPP Plan via an evaluation form.

Community Schools Steering Committee Meeting - Monthly community schools meetings will address any concerns parents have and will also provide parents will school and community resources to support them during virtual learning. Parents will hear updates on current academic and climate data and will have the opportunity to provide input to improve our practice.

Description: Central office support services will continue from various offices in PGCPS, who work on enhancing the learning process at respective schools. These members include the Instructional Director, Title I, ESOL Office, Human Resources, Technology, Curriculum and Instruction, Executive Leadership Offices, and the school based team. The team will meet quarterly to discuss how the services of the central office can assist the school based instructional program through professional development, funding, model lessons, coaching, and/or implementation and monitoring of our SPP action steps.

\_\*\*Extended Learning Program\*\*\_ (ELO)

Description: Community School funds will be used to support the ELO program. The goal of the extended learning opportunity is to increase academic achievement for our intermediate ELL students in the areas of reading and math. Imagine Learning is used as the instructional tool for this after school program.

\_\*\*Community Schools\*\*\_

Description: As a Community school we have support services provided by the Department of Social Services and both the current and former Mayor of Bladensburg, which serves to support wrap-around services for students' social emotional needs, instructional needs, and community needs. Community Schools supports our school's goal to improve culture and behaviors through the teaching of expectations and support.

Partnering with local political and business leaders, we are able to offer gang awareness sessions, health fairs and job interns for students. Senator Malcolm Augustine, Rev. Gail Addison, Dr. Artie Travis, and Pastor Jack Morris are local leaders who provide materials, speakers, and resources for our community, students, and parents on topics to enhance awareness and break down barriers to education.

The culmination of collaboration with Title I, district leaders, extended learning programs, community schools, along with parenting with community resources, supports learning of all of our students. It helps us to ensure that all children have fair, equal, and significant opportunity access with obtaining high quality instruction and reach, at least, proficiency on county, state and national academic achievement standards
